

THESE REGISTRATION AND EVENT TERMS (THE "TERMS" OR "AGREEMENT") GOVERN YOUR REGISTRATION AND PARTICIPATION IN THE EVENT DESCRIBED IN THE DOCUMENTATION TO WHICH THESE TERMS ARE LINKED TO OR ATTACHED (THE "EVENT"). THIS AGREEMENT IS BETWEEN YOU AND LIFERAY INTERNATIONAL LIMITED, A CORPORATION HAVING ITS PRINCIPAL PLACE OF BUSINESS AT 100 MOUNT STREET LOWER, DUBLIN 2, DUBLIN, IRELAND ("LIFERAY"). AS USED HEREIN "you" or "your" means you, the individual accepting these Terms, and/or if applicable the company or other legal entity for which you are accepting these Terms.

Registration

All individuals attending the Event ("Attendee(s)") must register for the Event through the indicated third party registration service ("Registration Service") by submitting the requested information ("Registration Information") into the appropriate fields (the process collectively the "Registration"). Liferay reserves the right to cancel or terminate any Registration at any time. You will receive an email confirming your Registration at the email address You provide during Registration. Liferay may modify these Terms from time to time. Liferay will notify You of such modification. You understand and agree that participation by You or an Attendee on Your behalf at the Event after such modification, signifies Your acceptance of the terms as modified.

Privacy Notice

- Attendees subject to GDPR

Liferay will handle and protect Your Registration Information provided in accordance with this Privacy Notice and the applicable laws and use it as required for the performance of this Agreement in accordance with Art. 6 (1)(a) of the GDPR.

Furthermore, Liferay may use certain Registration Information, specifically, the provided (a) name, (b) job title, (c) contact information including email address, (d) demographic information including but not limited to postal code, indicated preferences or interests and (e) any other information You might provide to Liferay in the context of Your registration for the Event relevant to customer surveys and/or offers in accordance with Art. retaining, using, or disclosing Personal Data for any commercial purpose other than the specific purpose of Liferay's performance under this Agreement.

2. To the extent that Liferay reserves rights under the Agreement to "aggregate" or "aggregated" Personal Data, Liferay agrees that the CCPA definition of Aggregate Consumer Information applies to such Personal Data and will process such Personal Data, accordingly.
3. To the extent that Liferay reserves rights under the Agreement to "de-identified," "anonymized," or "anonymous" Personal Data, Supplier agrees that the CCPA definition of De-identified applies to such Personal Data and will process such Personal Data, accordingly.
4. Notwithstanding the foregoing and for the purpose of addressing other prospective data protection laws, Liferay shall not Process any information provided by you that relates to, either directly or indirectly, an identified or identifiable individual (regardless of where that individual resides) other than for the specific purpose of Liferay's performance under this Agreement.

Sponsors

Payment

If applicable to the Event, Liferay will issue an invoice for the amounts indicated in the documentation to which these terms are attached or linked to (the "Fee") upon receipt and acceptance of Your Registration. You will pay the Fee no later than thirty (30) days from the date of receipt of a correct invoice, but in no event later than check-in on (a) the day of the Event or (b) the first day of an Event taking place over multiple days. Full payment of the Fees is required to gain access to the Event. Liferay reserves the right to deny any Attendee admittance to the Event if payment is not received in accordance with this Section. If You are paying the Fee by credit card, You hereby authorize the Registration Service, to charge your credit card for the Fee. The Attendees are responsible for organization and cost of travel and accommodation.

Badges and Check-In

- In person Events

Upon arrival all Attendees must check-in for admittance to the Event. You must provide a valid government issued photo ID to check-in. Liferay will issue all Attendees an identification badge upon check-in. Badges will not be issued without an ID, and Attendees will not be admitted to the Event without a Badge. You are required to wear your badge at all times at the Event. Liferay reserves the

right to verify You are wearing the correct badge at any time during the Event. Liferay reserves the right to remove You from the Event if You are not wearing a badge issued by Liferay to You.

- Online Events

If the Event is held virtually, Attendees agree to use only the Liferay designated online platform for the Event. Attendees agree to use the login credentials provided by Liferay and will not share these credentials with any other individual or Attendee. Liferay reserves the right to remove any Attendee that has violated these Terms.

Unacceptable Behavior

Attendees are expected to be considerate and respectful of others at the Event. Compliance with the terms of this section is mandatory for participation in the Event.

Attendees agree to refrain from demeaning, discriminatory or harassing behavior, materials and speech. Unacceptable behaviors & materials include but are not limited to: (a) intimidating, harassing, abusive, discriminatory, derogatory, or demeaning materials or conduct by any Attendees of the Event and related Event activities, (b) offensive comments (verbal, written, or otherwise) related to gender, sexual orientation, race, religion, disability; inappropriate use of nudity and/or sexual images in public spaces (including presentation slides); deliberate intimidation, stalking or following; harassing materials, photography or recording; sustained disruption of talks or other events (whether verbal or otherwise); inappropriate physical contact, and unwelcome sexual attention, (c) physical, written, verbal or other abuse, intimidation, threats, annoyance, harassment, stalking, pushing, shoving or use of any physical force whatsoever against any person, which in any way creates a disturbance that is disruptive or dangerous, or creates apprehension in a person, as determined by Liferay, in its sole discretion, (d) possession of any item that can be used as a weapon, which may cause danger to others if used in a certain manner, (e) any boisterous, lewd or offensive behavior or language, including but not limited to using sexually explicit or offensive language, materials or conduct, or any language, behavior or content that contains profanity, obscene gestures, or racial, religious or ethnic slurs, (f) possessing any open can, bottle or other receptacle containing any alcoholic beverages, except in areas specifically designated for the consumption of alcohol.

If anyone engages in unacceptable behavior, Liferay may take any action it deems appropriate, up to and including expulsion from the Event without warning or refund.

If Attendees are subjected to unacceptable behavior, notice that someone else is being subjected to unacceptable behavior, or have any other concerns, please notify Liferay as soon as possible.

Government Officials



All government employees or officials who register to attend the Event must identify themselves as government employees or officials to Liferay. If a government employee or official is offered free or discounted attendance at the Event, the government employee or official may be asked to confirm that s/he has disclosed his or her attendance at the Event to their employing government agency in advance and that their employing agency has provided permission for the employee to accept free or discounted attendance at this Event. Each government employee or official who attends the Event also must confirm that (s)he will abide by all relevant rules and regulations imposed by his or her employing agency during this Event, including those rules and regulations relating to the acceptance and disclosure of gifts and gratuities. Any Government employee or official who attends the Event may be asked to present his/her government issued employee badge at Event check-in.

Safety and Security

Liferay reserves the right to take any security measures it may deem appropriate related to the safety of the Event. Compliance with Liferay requests related to the safety and security of the Event is a precondition for an Attendee's continued participation in the Event after such request is made.

Cancellation and Substitutions

Liferay will honor any cancellation request made at least fifteen (15) days prior to (a) the day of the Event or (b) the first day of an Event taking place over multiple days. Attendees that request cancellation in accordance with the preceding sentence shall be provided a refund of the Fee.

An Attendee that has completed Registration may substitute another person to attend the Event in place of such Attendee up until (a) the day of the Event or (b) the first day of an Event taking place over multiple days, by updating the appropriate Registration Information on the Registration Service.

Software

Certain optional workshops, breakout sessions, and training sessions at the Event may involve the use of certain software by Attendees. You understand that use of such software and participation in such sessions is completely voluntary. As the specific software may vary based on the workshop, breakout session, or training session the terms related to the use of the specific software will accompany such software.

Personal Release

Liferay or others on behalf of Liferay, may be photographing, audio and/or video recording, webcasting, and podcasting at the Event. This includes, but is not limited to keynotes, breakout session, technical sessions, and other activities. You agree that Liferay may use and/or share with Liferay's Affiliates, your image or likeness, if captured, in connection with any advertising or promotional content, program, or material for Liferay business and projects, or for any other lawful



purpose, including by posting on public websites. Liferay is not, however, obligated to make any use of your image, name or likeness, or exercise any of the rights granted to it. You also understand that your image may appear in Liferay photos made available to you, other attendees, or the public, and that these third-parties may retain and distribute those photos. As used herein, "Affiliate" means an entity that owns or controls, is owned or controlled by, or is under common control or ownership with a party, where "control" is the possession, direct or indirect, of the power to direct or cause the direction of the management and policies of an entity, whether through ownership of voting securities, by contract or otherwise.

Photography and Recordings

Liferay expressly points out that all of Your actions relating to photos, audio and/or video recordings, webcastings, podcastings, or alike, including but not limited to shots, publications and modifications, are subject to the applicable law, including but not limited to copyright law, in each case for both private and commercial purposes. Your such actions may, in any case, require the express prior consent of Liferay, its Affiliates, the property owner, the copyright holder, the depicted person and/or, in each case, its duly authorized agent, among others. You are solely responsible for obtaining such prior consent. You expressly agree to follow any written, verbal or otherwise communicated restriction. Furthermore, You accept to be excluded without warning from the Event and without refund of any Fees, if applicable, in case of any non-compliance by You.

Force Majeure

Liferay will not be held liable and no refund will be made, in the event of the cancellation or modification of the times, dates, sessions and/or the Event in whole as a result of an event that is beyond Liferay's control, including but not limited to inclement weather, earthquake, flood, or other act of God, war, invasion, act of foreign enemy, hostilities, riot, national state of emergency, plague, act/threat of terrorism, civil unrest, strikes or other labor disputes, or any other similar or related event which delays or prevents any or all of the Event.

No Warranties

LIFERAY MAKES NO WARRANTIES OF ANY KIND WITH RESPECT TO THE EVENT OR REGISTRATION, WHETHER EXPRESS, IMPLIED, BY STATUTE OR OTHERWISE, AND LIFERAY SPECIFICALLY DISCLAIMS ALL IMPLIED WARRANTIES, INCLUDING ANY WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW. WITHOUT LIMITING THE GENERALITY OF THE FOREGOING, LIFERAY DOES NOT REPRESENT OR WARRANT THAT YOUR ATTENDANCE OF THE EVENT WILL MEET YOUR REQUIREMENTS OR THAT YOUR ATTENDANCE OF THE EVENT WILL BE UNINTERRUPTED, TIMELY, SECURE OR FREE FROM ERROR.

Limitation of Liability

To the maximum extent permitted under applicable law, under no circumstances is Liferay, or any of its respective parents, affiliates, shareholders, employees, agents, officers, directors, successors, and assigns (the “Event Providers”) liable for lost profits, lost data, or other indirect, incidental, consequential, special, or other exemplary damages for any of their acts or omissions in connection with the Event, whether or not such Event Provider has been apprised of the possibility of such damages. In no event will Liferay’s liability hereunder, or otherwise in connection with the Event, exceed the amount actually paid by You for the Event.

None of the Event Providers are liable to You or Attendees for any damage, loss, harm, or injury to the person, property, or business resulting from theft, fire, earthquake, water, unavailability of the venue, insufficient participation, accident, or any other reason in connection with the Event or any planning, meetings, demonstrations, workshops, or staging.

Nothing in this Agreement shall limit or exclude the liability of the Event Providers in the following circumstances: (i) fraud, fraudulent misrepresentation or willful misconduct; or (ii) death or bodily injury caused by the negligence of an Event Provider or its affiliates.

Governing Law and Jurisdiction

These Terms and any disputes arising out of or related hereto, shall be governed exclusively by the laws of Ireland. The courts located in the city of Dublin, Ireland shall have exclusive jurisdiction to adjudicate any dispute arising out of or relating to these Terms. Each party hereby consents to the exclusive jurisdiction of such courts.

Waiver of Jury Trial

Each party hereby waives any right to jury trial in connection with any action or litigation in any way arising out of or related to these Terms.

Relationship of the Parties

These Terms and the activities governed hereby; do not create a partnership, franchise, joint venture, agency, fiduciary, or employment relationship between the parties.

Waiver and Cumulative Remedies

No failure or delay by either party in exercising any right under these Terms shall constitute a waiver of that right. Other than as expressly stated herein, the remedies provided herein are in addition to, and not exclusive of, any other remedies of a party at law or in equity.

Severability and Assignment

If any provision in these Terms is held by a court of competent jurisdiction to be contrary to law, the provision shall be modified by the court and interpreted so as best to accomplish the objectives of the original provision to the fullest extent permitted by law, and the remaining provisions of these Terms shall remain in effect.

You may not assign any of your rights or obligations hereunder, whether by operation of law or otherwise, without the prior written consent Liferay. Liferay's sole remedy for any purported assignment in breach of this paragraph shall be termination of this Agreement and non-participation in the Event. Subject to the foregoing, these Terms shall bind and inure to the benefit of the parties, their respective successors and permitted assigns.

Entire Agreement

These Terms constitute the entire agreement between the parties in relations to the Event and Registration and supersede all prior and contemporaneous terms, agreements, proposals or representations, written or oral, concerning its subject matter.

YOU REPRESENT AND WARRANT THAT YOU ARE AUTHORIZED TO ENTER INTO THIS AGREEMENT AND THAT YOU CAN AND WILL COMPLY WITH ALL THE TERMS OUTLINED HEREIN.
